However Branch Diving Officer's can judge additional experience and training on a case by case basis.</p>	<p>Advanced Diver</p>

Notes on the Table of Similar Qualifications

1. 'Try a Dive' Programmes such as the Go Dive or Try Dive campaigns do not include sufficient instruction to warrant any credits / exemptions from a full programme of BSAC diver training.
2. BSAC will normally accept other agency Snorkelling Qualifications as directly equivalent to its own.

Nothing in the SALT process removes or alters the Branch Diving Officer's responsibility for the safety and well being of Branch members. If the DO feels that the skills of a new member, originally trained by another agency, are lacking, the DO is at liberty to require the member to undertake appropriate refresher training and/or limit their open water diving activities until a satisfactory level of skills performance is demonstrated.
